8th Grade Social Studies U.S. Studies From 1492 to 1877: Exploration Through Reconstruction

The historical focus continues in the eighth grade with the study of European exploration and the early years of the United States. This study incorporates all four social studies strands into a chronologic view of the development of the United States. Students examine how historic events are shaped by geographic, social, cultural, economic and political factors.

Quarter 1

Topics Covered: Native Americans, European exploration of the Americas, their colonies including their economies and slavery

Skills: Use advanced search techniques to locate needed information using digital learning tools and resources. Primary and secondary sources are used to examine events from multiple perspectives and to present and defend a position.
